## SECRETARY REPORT/CHIEF DELEGATE MDA RECAP: Dr. Sue Carron

DDDS presented three resolutions at the MDA-HOD. Two resolutions on membership for life membership age limits were presented. We produced a lot of discussion on the floor of the HOD. They thought since membership dues had been brought up numerous times, the past ten years, the last change in 2021, delegates thought the issue did not need to be discussed. BUT there is HOPE because President-elect Todd Christy see things differently, because younger members are not engaging (not enough time) and older members see no need to continue because no limits or discounts, after age 65 and if they are still working some. The application for a waiver and how It works is not totally understood, either. The Trustees will refer this concern on life membership to the Membership committee, as stated in the MDA reference committee report 2023., per Dr. Marv Sonne. Dr. Vince Lizzio said he would help Detroit write new resolutions on the membership area and on transparency of funds needed from nonreserves. It felt like it was Detroit vs. Everybody. MDA is just following what the ADA decides, without looking at the effect on membership numbers. ELECTIONS: Dr. Vince Lizzio (one more year in his term) and Dr. Melanie Mayberry (elected for three more years) are our Trustees-atLarge. Dr. Tamika Thompson was elected an Alternate Delegate for the ADA HOD 2023.

Our give- away of Hand Sanitizer with the D.E.T. logo and dated was a BIG hit. Hand Sanitizer keyrings were given to people with the saying" for your Hands and remember there are HandsOn classes included for the day, November 3, 2023". Marcy and Marvin walked the exhibit floor, together, to recruit exhibitors and sponsors for DET. Patterson's manager, Mr. Chad Cunningham
said he would help sponsor Zoo Day in 2024 and an exhibit at D.E.T. 2023. Marvin thought the entrance to the exhibit hall should have had a large sign Listing all the MDA Legislative accomplishments in 2022, for all to read upon entering.

Dr. Chris Gorecki visited our Caucus on Saturday to discuss the use (transparency) of nonreserve funds. The 2022 year, a total of $\$ 200,000$ was withdrawn from Non-Reserve Funds; for 2022 projects that the yearly budget passed in September 2021, were not include for year 2022. We thought a list composed of one or two pages to delegates would help explain the need for and importance of the needed withdrawal. Also, to help explain, to members, where our money was needed/spent in addition. We suggested to Dr. Gorecki, that as treasurer, he could start this process for the year 2023 to present to 2024 HOD.

Detroit had 16 wonderful enthusiastic delegates! All participated and spoke at the microphone. Dr. Steve Harris wrote on a voting card at the end to everyone: "GREAT JOB EVERYONE, We generated Debate, put forward three resolutions, successfully substituted a \#10 ( Resolution \#10-Report on non-reserve spending) and amended it, and though we lost- We worked the process like CHAMPS!" Thank you notes were written by Sue Carron to all delegates and the two who had family issues and could not be there.

TREASURER REPORT: Dr. Yuksel Erpardo
The Budget for Year 2023 has been finalized.
ACTION ITEM: MARCY please attach the budget as it was finalized to the minutes:

- Expenses: $62 \%$ for Program $38 \%$ for Administrative and overhead expenses
- Separate Budget for the D.E.T. Symposium November 3, 2023, and Special Thursday Night, November 2, 2023.
- Income: will be reduced due to fewer members. We need to engage young members to understand the importance of Tripartite membership and need to make personal connections. Also need to connect with senior members and make sure they get the waivers needed. Budget as presented has a Profit of $\$ 158.91=$ break even budget
- Our CPA was able to get COVID funds from PPE of $\$ 19,900$. Do not know if there will be any taxes, we are a non-profit organization, but it is determined by our income and expenses. The monies are to benefit the members. Around $\$ 17,000$. The Scientific Committee asked if we could save it, to act as a buffer for the D.E.T. expenses and not use reserve funds. The D.E.T. budget is a break-even budget, too. Discussion held to agree with Scientific committee. Bottom Line: funds to be used for CE for members at no cost, for some programs.
- ACCOUNTS: Comerica Checking: \$95,460

Gorman Investment: need current amt: About \$100,000
Money Market: \$4321.46 connected to Gorman Acct.
Ford Investment Acct: \$1531.99 Marcy and Yuksel need to close the
Account at end of quarter and transfer funds to Comerica Checking
Comerica CD: \$100,000 (By end of quarter/June 2023) ACTION ITEM

Motion: To Approve the 2023 Budget that was discussed over the last two meetings. Motion made by Dr. Sona Fisenkova and seconded by Dr. Claudia Menton. Call for the vote as no further discussion is needed. Passed Unanimously.
