Dinner was Buffet at 6:30 PM. Dean Mert Aksu joined us. He was very informative about what the dental students need and want from organized dentistry and trends in practice settings for new and young dentists. He would be a great speaker for another meeting on the "Future of Dentistry, next five years". Dr. Aksu besides being Dean since 2008, he is a lawyer, MHSA, Cert. DPH. He was Awarded ADEA's Gies Award for Vision-Dental Educator, 2021.

Meeting was called to order by President Dr. Jehan Wakeem at 7:10 PM. The agenda was approved. Dr. Wakeem introduced our guests. Our new DDDS Student Representative was present, Ms. Mary Matta, D3 student and her friend, Mr. Mo, also a D3 student. Contact information for Mary: mattamy@udmercy.edu

Dr. Wakeem gave an update on the New Dental Hygiene program at Macomb Community College. This is a replacement for Baker College program. She teaches on Tuesdays. Thirty students will be graduating in Spring 2024. Dr. Wakeem stated we are still looking for volunteers for branch officers. She asked all of us to recruit members at our upcoming Branch meetings. New dentists are welcomed.

Dr. Wakeem and Marcy both reviewed our upcoming education day DET 2023 on November 3, 2023, at the Detroit Dearborn Double Tree Hotel. Registrations for

With older members retiring or not coming to meetings, the MDA and DDDS is really looking to expand contact with young dentists and engage them into the MDA and local Districts. We also need to keep older members engaged because they have a wealth of knowledge to share with us all. Remember our sponsors want to connect with our members. This discussion is in relationship to "Just Detroit District". We have "found monies from closing our Dearborn office at the end of October, Marcy will be working remotely, money from a Covid subside from our CPA efforts, Grants we were granted from the ADA and MDA.

Long-term Members' Dues Discount Program/Lifetime Members: Discount at age 65, and Doctor has been a continuous member for 5 years prior to age 65. Members are at different thresholds: If they participate in two activities, get portion of dues refunded back to them. Ways to participate: Volunteers for ten hours of community service. Attend two Detroit District Functions, Sit on an MDA, ADA, government, or other dental board or leadership position and report to the Detroit District Council.

Free Dental Clinics to volunteer with: MALTA, Detroit; Gary Burnstein Clinic, Pontiac; TEAM SMILE with the Lions, October 20, 2023, Detroit; Mission of Mercy, June 13 to 16, 2024, Dort Areana, Flint Area.

CE Day/ All Membership DDDS presents two Full CE Days, with one being DET 2023 the other day will help members attend classes needed for their State License Renewal every three years. Classes needed that the education committee can pick from: One time Human Trafficking- 1 HR, One time Opioid Awareness-1 HR, CPR Class, Ethics-1 HR, Pain Management-3 HRS, Infection Control-1HR-must

include Hand piece sterilization, Implicit Bias- 3 HRS- on demand, recorded or in person (counts toward 60 HRS of required CE), New Requirement from DEA 2023- 8 HRS separate from Pain Management.

All Day/ CE could coincide with All Branch meeting for Detroit District. Members would like free CE, because they can receive free CE from Many businesses and companies.

Dental Student Engagement/Resources/ new dentists A lot of this is being done by the MDA. We need to survey our membership and possible membership what they want. Try to Focus on three events per year. IE: Red Wings Game, Ask Me Anything evening, Zoo Day. Note: must be student/ member driven

Ask at branch meetings and DDDS sent survey at the beginning of August to membership.

Member Benefits promotion- pick three benefits annually and create a communication/ participation/ the education of benefits.

All- Branch Meeting free to members: who attend all 4 branch meetings, or volunteer 8 hours for community service I.E. Malta, Team Smile, Gary Burnstein Clinic, Vina Clinic, or are on MDA/ ADA/ DDDS committee and report back to Council. Combination of 10 hours giving back

In Depth Member Survey- All Members. One done on CE topics, August 2023, one done on who takes Medicaid, sedation, wheel chair bound patients- Done August 2023.

Mentorship for new members/ engagement of members, work with MDA, get ideas from Macomb and Oakland Districts. New members handbook or young Dentist handbook, ?? Is MDA/ADA working on this.

Host pre -event for a New Dentist meeting before All Branch, CE days, Branch. Note from Oakland: New dentists are not available on Fridays because they have to cover the office. Our pre New Member meeting is Thursday night before DET 2023 Friday Day meeting/ hopefully good time. Young Dentists do not see the value of in person meetings for networking, they use Instagram, snap chat, etc. Also, they can get their CE hours via Zoom or On- demand classes. Note: A minimum of 20 hours for dentists must be done in a classroom setting or a real time live webinar. You tube videos for new techniques, do not count for CE, unless in real time. Cost is also a factor. Many companies are offering FREE CE. You do not need CE to attract members, if the event is stand-alone I.E. Red Wings Game, Pistons Game, Tigers Game, Zoo Day, Bar Biking in Detroit, and volunteering for underserved clinics.- Team Smile, MoM.

Spend money to improve communications. Email, newsletter, etc The ADA is updated their email site, web site for communications, which will go live summer 2024. Marcy is on the committee to evaluate site.

Create Dental Posters for practices to promote what organize dentistry does for the public.

Education for dental staff- Remote or in-person lunch and Learn. Information gathered for dental offices to save dentist time in gathering contacts. Can also include zoom recordings of DDDS CE courses.

The list from the MDA from other meetings with Young Dentists on what is important for them.

MDA Chat n' Chill (Strictly for New & Early Career Dentists in February 2023 & August 2023) Notes/Findings: From Sophie Brenke, MDA Component Relations

- They are facing financial concerns from excessive student debt
- They want to own a private practice, but barriers are money constraints and lack of education on how to effectively run a business
- Many aren't familiar with the MDA website or social media
- They identify that DSO's have pros and cons but must work at a DSO until they can afford a private practice and believe that the future will be 80% DSO
- They don't want to work in rural areas, so they want to stay in Detroit (also because of family)
- They do not want CE on Fridays older/seasoned dentists can make those meetings, but New & Early Career Dentists cannot
- They request more social events and don't need a CE speaker to join in order to attend
- They were interested in MDA committees and other leadership but weren't fully aware of open opportunities
- Most want to do a specialty career to make more money
- Enjoyed the mentors they had but wished there was more of a lifelong connection
- They do want in person events
- Weren't clear on which component they're a part of or who their component executive is (Oakland seemed to be the most aware)
- Requested and suggested an onboarding toolkit for new dentists
- Didn't fully understand the tripartite membership
- Main reasons they went into dentistry was to help people and make money
- Reported that most CE speakers are "outdated and too old to relate to"
- High interest in women in dentistry club
- Examples of Dentists that attended (Did not provide names to ensure privacy):
 - (Early Career) Dentist 1 Works at both a private practice and DSO, Single, 26, living with parents, considered dropping membership due to lack of value
 - (New Dentist) Dentist 2 Works as an orthodontist at their own private practice,
 29, a parent and married, mom helped her through school and with new child
 - (Early Career) Dentist 3 Work at DSO and two private practices (works with two other dentists at both private practices), single, 26
 - Dentist 4 Worked as and enjoyed being a DSO but saw 20+ patients per day and burnt out. Also, felt like they were looped into leadership (LEAD program/other leadership opportunities) and feeling burnt out, works at private practice, married, 35


2023 approved budget


Income \$ 210,750.00 Expense 191,815.00 Profit \$ 18,935.00

The biggest variable is DET2023 for the budget. The Dental Review in 2022 lost money. The Dental Review in prior years had been breakeven. DET2023, this year new ideas are being tried to attract more attendees with hands-on sessions and New Dentist dinner the night before. We noted that some of the income from the Covid Employee Tax Credit we received may be cushion if this event is not profitable. Right now, the concern is that registrations are very low for this event.
